### Residents Rights (ADMISSION, TRANSFER, DISCHARGE)

EACH RESIDENT has the right not to be discriminated against by the facility in any way based on the resident's source of payment. A facility may not require resident or potential residents to waive their rights to Medicare or Medicaid; require assurance that residents or potential residents are not eligible for Medicare or Medicaid benefits, or require a third party guarantee of payment as a condition of admission or expedited admission. Nor can the facility charge, solicit, accept or receive as a per-condition of admission, expedited admission, or continued stay in the facility under the state plan anything of value, over and above what is lawfully required to be paid except a charge may be made for items and services the resident requested and received that are not "nursing facility services" under the state plan so long as the facility gives proper notice.

- When finished with your visit, please DO NOT wander the hallways. Please call the facility and we will come assist your loved one and/or let you out of the building.

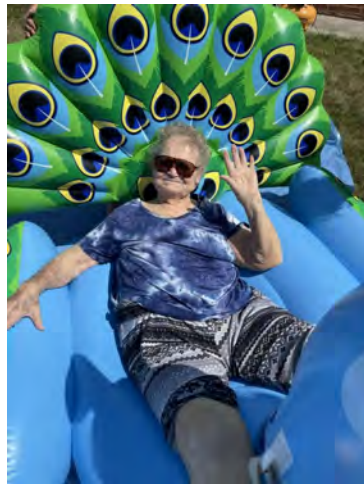
