RESIDENTS RIGHTS

(Admission, Transfer, Discharge)

EACH RESIDENT has the right to have the resident's bed held under designated circumstances and upon payment of the prescribed charge for the bed. Each resident and a family member or legal representative has the right to receive before transfer or leave written in information explaining the designated circumstances and relevant policies. If a resident's transfer or therapeutic leave exceeds the state approved bed-hold policy and the resident continues to require the services of the facility after hospitalization or therapeutic leave and is eligible for financial assistance, such resident shall be re-admitted to the facility as soon as a bed in a semi-private room becomes available.

These alarms are required by state law and are in place as an important safety measure for our residents.

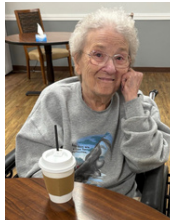
Very Important: Never assist a resident (unless it is your own family member) out of the building. If you see a resident leaving unattended, alert a staff member immediately.

And don't forget—before leaving the building, **please sign your resident out** at either the nurses' station or the front door.

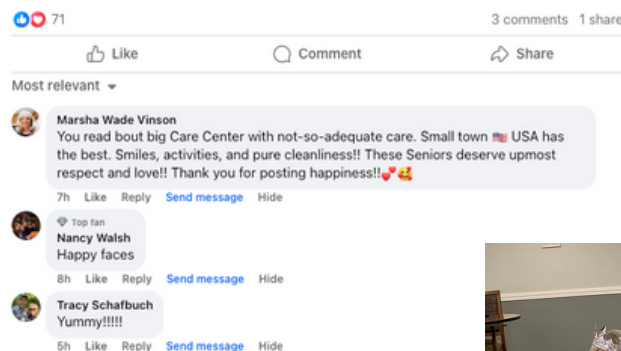

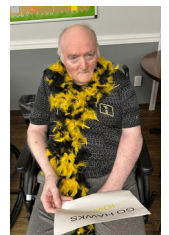
